- 1. Participants (each an "EIPA Participant") of the scheme of Expression of Interest in Purchasing Arrangement in relation to the Development ("EIPA") (Note: please see "Other matters" below) and not other persons may select the specified residential properties offered to be sold under these Sales Arrangements on the Date of EIPA Sale. Details are as follows.

- 2. The EIPA Participants who are eligible to purchase and interested in purchasing any of the specified residential properties offered to be sold under these Sales Arrangements shall <u>personally attend</u> the City Hub Sales Office between 9:00 a.m. and 9:30 a.m. on the Date of EIPA Sale (i.e. 20 February 2018) to complete and personally sign the prescribed form of Registration of Intent and must bring along:

符合資格及有意購買本銷售安排提供出售的指明住宅物業的「認購意向安排計劃參與人」須於「認購意向安排計劃出售日期」(即 2018 年 2 月 20 日)上午 9 時至上午 9 時 30 分內<u>親臨</u>津匯售樓處,以填妥及簽妥購樓意向登記指定表格並須攜同以下文件:

- (a) his/her H.K.I.D. Card(s) or Passport(s) (as the case may be); 其香港身份證或護照 (視屬何情況而定);
- (b) a cashier order issued in favour of "Mayer Brown JSM" for the sum of HK\$100,000 for payment of part of the preliminary deposit payable upon signing of the Preliminary Agreement for Sale and Purchase; and

3. The EIPA Participants who arrive at the City Hub Sales Office at any time later than 9:30 a.m. on 20 February 2018 shall not be eligible for any balloting. The Registration of Intent is personal to the EIPA Participant and shall not be transferrable.

4. The EIPA Participants whose identities have been confirmed and verified by the Vendor during the registration shall be eligible for the balloting. The priority of selecting and purchasing the specified residential properties among the EIPA Participants eligible for the balloting (each "Registrant") will be determined by balloting, and each Registrant can only select and purchase one specified residential property.

- 6. The Registrant of each Registration of Intent shall proceed to select one (1) specified residential property which is still available at the time of selection in order of priority according to the ballot result. In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any Registrant interested in purchasing.

- 7. If the Registrant has successfully selected any specified residential property, the Registrant will be offered to view the selected specified residential property prior to entering into the preliminary agreement for sale and purchase.

- 8. The Vendor reserves the right at any time, for the purposes of maintaining order at the City Hub Sales Office and/or facilitating smooth sale of the specified residential properties, to adjust the time of the selection and sale. Any changes to the time of the selection and sale will be posted at the City Hub Sales Office. The Registrants will not be notified separately of such changes.

If the Registrant has successfully selected a specified residential property, the Registrant shall personally enter into a Preliminary Agreement for Sale and Purchase of the selected specified residential property. If the Registrant shall fail to enter into a Preliminary Agreement for Sale and Purchase for the selected specified residential property, the Registrant shall be immediately disqualified from selecting and purchasing the specified residential property and the selection of

specified residential property made by the Registrant shall be cancelled.

## Other matters

其他事項

(a) The Expression of Interest in Purchasing Arrangement ("EIPA") mentioned herein is a scheme run by the Vendor - Urban Renewal Authority. The intention of that scheme is to offer opportunity to the former owner-occupiers of domestic flats in the Urban Renewal Authority's Project TKW/1/001 (Chi Kiang Street/Ha Heung Street) to purchase residential properties in the Development for moving back to the same district where they once lived. The participants of that scheme will be informed, after the issuance of these Sales Arrangements, by a registered letter issued by Urban Renewal Authority of the sales arrangements hereof.

本文所提及之認購意向安排計劃乃賣方:市區重建局專為受 TKW/1/001 項目(即浙江街/下鄉道發展計劃)影響的前住宅物業自住業主而設,旨在提供機會予該等前業主購買發展項目的住宅物業以返回該區居住。已參與該計劃之人士於本銷售安排發出日期後將獲市區重建局的掛號函件通知本銷售安排。

- (b) The sale of the 5 specified residential properties contained in this Information on Sales Arrangements is an one-off arrangement; and there will be no other residential properties in the Development or in other future developments falling within Urban Renewal Authority's Project TKW/1/001 (Chi Kiang Street/Ha Heung Street) designated for sale under the EIPA.

properties in the Development offered to be sold under other Sales Arrangements issued or to be issued by the Vendor from time to time.

- (f) If No. 8 or higher Tropical Cyclone Warning Signal is hoisted and/or Black Rainstorm Warning Signal is issued by the Hong Kong Observatory at any time between the hours of 8:00 a.m. and 12:00 noon on the Date of EIPA Sale (i.e. 20 February 2018), then, for the safety of the EIPA Participants and the maintenance of order at the City Hub Sales Office, the Vendor may, at its absolute discretion, (i) postpone the Date of EIPA Sale (i.e. 20 February 2018) to the following day after the No. 8 or higher Tropical Cyclone Warning Signal is cancelled or replaced by a No. 3 Tropical Cyclone Signal or below and/or after the Black Rainstorm Warning Signal is cancelled or replaced by a lower level alert (as the case may be) and/or (ii) close the City Hub Sales Office. EIPA Participants will not be notified separately of the above arrangements.

如於「認購意向安排計劃出售日期」(即 2018 年 2 月 20 日)上午 8 時至中午 12 時期間香港天文台發出八號或以上熱帶氣旋警告信號及/或黑色暴雨警告信號,賣方為保障「認購意向安排計劃參與人」的安全及維持津匯售樓處的秩序,賣方將有絕對酌情權(i)延遲「認購意向安排計劃出售日期」(即 2018 年 2 月 20 日)至八號或以上熱帶氣旋警告信號取消或改為三號或較低的警告信號後的之後的一天及/或黑色暴雨警告信號取消或改為較低級別的暴雨警告信號後的之後的一天(視情況而定)及/或(ii)關閉津匯售樓處。「認購意向安排計劃參與人」將不獲另行通知上述安排。
