**On 30 January 2018:**

### Balloting

Balloting will be used to determine the order of priority. The person(s) or company(ies) interested in purchasing any of the specified residential properties (“the registrant(s)”) must follow the procedures below:-

1. To participate in the balloting, interested persons must first submit a registration of intent using Registration of Intent – Form A (“Group A Registration of Intent”) and / or Registration of Intent - Form B (“Group B Registration of Intent”) (collectively the “Registration of Intent” and each a “Registration of Intent”).
2. Registrants submitting the Registration of Intent will be divided into two (2) groups of balloting, i.e. Group A and Group B in accordance with the forms of the Registrations of Intent they submitted, to determine the order of priority for selection of the specified residential properties.
3. Each of the registrants (or his/her authorized person) must submit the following to the Novum Point Sales Office, L5, Mira Place One, 132 Nathan Road, Tsim Sha Tsui, Kowloon (“the designated venue”) during the period from 20 January 2018 to 29 January 2018 during office hours (i.e. from 10:30 a.m. to 8:00 p.m. on Monday to Sunday) (The order of registration will not have any impact on the order of priority for selecting the residential property):
  - (a) a maximum of one (1) Group A Registration of Intent and one (1) Group B Registration of Intent duly completed and signed by the registrant. Duplicated submission will not be accepted; and
  - (b) the Registration of Intent shall be accompanied with cashier order(s).
    - (i) Group A registrants must submit two (2) cashier orders, but the number of residential property(ies) to be selected in any event shall not less than two (2);
    - (ii) Group B registrants can submit a maximum of two (2) cashier order(s), but the number of residential property(ies) to be selected in any event shall not exceed two (2).Each cashier order shall be in the sum of HK\$100,000 and made payable to “Zhong Lun Law Firm”; and
  - (c) a copy of the registrant’s I.D. Card(s) or Passport(s) (as the case may be) or copy of Business Registration Certificate or Certificate of Incorporation and the I.D. Card of the Director of the registrant (if applicable).The closing time for submission of Registration of Intent will be 8:00 p.m. on 29 January 2018.
4. The cashier order(s) will be used as part payment of the preliminary deposit for the purchase of the specified residential property.
5. On 30 January 2018, the registrants (if the registrant is a company, then any one of its directors) who have submitted the registration in accordance with paragraph 3 above shall personally attend the designated venue between 6:00 p.m. and 7:00 p.m. (“check-in time slot for the registrants”). The registrants must bring along their I.D. Card(s) or Passport(s) (as the case may be) or Business Registration Certificate, Certificate of Incorporation, and I.D. Card of the Director of the registrant (if application) and the official receipt for the Registration of Intent. The registrants whose identities have been verified by the Agent appointed by the Vendor shall be eligible for the balloting. Any registrant who arrives at the designated venue at any time later than 7:00 p.m. on 30 January 2018 shall not be eligible for any balloting and the registration of such registrant will be deemed invalid.
6. The balloting for Group A registrants and Group B registrants will take place at 7:05 p.m. on 30 January 2018 and the balloting results, including “registration number” and “balloting result priority”, will be posted by the Vendor at the designated venue on 30 January 2018. Registrants will not be separately notified of the balloting results. Every

valid Group A Registration of Intent and Group B Registration of Intent shall be allotted such number of lot(s) which equals the number of cashier order(s) which the registrant(s) submitted with the Registration of Intent. Once a lot allotted to a Registration of Intent has been successfully drawn, all other lot(s) (if any) relating to the same Registration of Intent shall be cancelled and be treated as null and void.

7. On 30 January 2018, the sales of specified residential properties will be divided in to 2 sessions applicable to the following 2 groups of persons who have already submitted Registrations of Intent (each group will be referred to as a “Group”) (namely Group A and Group B).

(a) The Group A Selection will take place first. The registrants under Group A shall proceed to select the specified residential properties which are still available at the time of selection in the order according to the balloting result priority, once there only remains one (1) specified residential property which is still available for sale, the Group A will end.

(b) The Group B Selection will take place after the completion of the Group A as determined by the Vendor at its discretion. The registrants under Group B shall proceed to select the specified residential properties which are still available at the time of selection in the order of priority according to the balloting result priority.

(c) Where a registrant selects only one specified residential property in respect of a Registration of Intent, the purchaser(s) of that specified residential property shall only be:

- (i) That registrant; or
- (ii) That registrant together with one or more “Immediate Family Members” of that registrant whom that registrant requests the Vendor on spot to add as joint purchaser(s).

(d) Where a registrant selects more than one specified residential property in respect of a Registration of Intent:

- (i) The purchaser(s) of at least one so selected specified residential property shall only be:
  - (1) That registrant; or
  - (2) That registrant together with one or more “Immediate Family Members” of that registrant whom that registrant requests the Vendor on spot to add as joint purchaser(s); and
- (ii) The purchaser(s) of each other so selected specified residential property shall only be:
  - (1) That registrant (or any individual constituting that registrant); or
  - (2) One or more “Immediate Family Members” of that registrant whom that registrant requests the Vendor on spot to be the purchaser(s); or
  - (3) That registrant (or any individual constituting that registrant) together with one or more “Immediate Family Members” of that registrant whom that registrant requests the Vendor on spot to add as joint purchaser(s).

(e) “Immediate Family Member” of a registrant means a spouse, parent, child, sibling, grandparent or grandchild of that registrant. Purchasers have to bring along with the relevant valid supporting document(s) as a proof to the satisfaction of the Vendor.

(f) The Vendor reserves its absolute right to determine whether or not a participant is a qualified “Immediate Family Members”.

8. If a registrant has not purchased any specified residential property or the number of specified residential property(ies) being purchased is less than the number of specified residential property(ies) which the registrant intends to purchase as indicated in the Registration of Intent, his/her unused cashier order(s) will be available for collection without interest by the registrant (or his/her authorized person) at The Novum Point Sales Office during 31 January 2018 to 1 February 2018 (from 10:30 a.m. to 8:00 p.m.). The registrant must bring along the I.D. Card(s) or Passport(s) of the registrant (or a copy of the I.D Card(s) or Passport(s) of the registrant if unused cashier order(s) is/are collected by the authorized person), the original receipt of the valid Registration of Intent, and (if applicable) a valid authorization letter and a copy of the I.D Card or Passport of the authorized person.

#### First-come-first-served

After the completion of the balloting and the selecting and purchasing of the specified residential properties by the eligible persons in accordance with the above procedures, the order of priority in the selection of all the remaining specified residential properties (if any) will be on a first-come-first-served basis. For the purpose of maintaining order at the designated venue, the Vendor reserves the right to allocate a particular specified residential property to a particular interested person and determine to whom a particular specified residential property will be sold by any method (including balloting) in case of any dispute.

#### On 31 January 2018 and thereafter:

The order of priority in the selection of the remaining specified residential properties will be on a first-come-first-served basis. Persons interested in purchasing must personally attend the designated place where the sale will take place to purchase the remaining specified residential properties. For the purpose of maintaining order at the designated place, the Vendor reserves the right to allocate a particular specified residential property to a particular interested person and determine to whom a residential property will be sold by any method (including balloting) in case of any dispute.

#### 2018年1月30日:

##### 抽籤

以抽籤方式決定優先次序，有意購買該等指明住宅物業的人士或公司（下稱：登記人）須遵從下列程序:-

1. 有意參與抽籤人士，須先遞交購樓意向登記表，格式必須為購樓意向登記表 – 表格A（下稱：A組購樓意向登記表）及/或購樓意向登記表 – 表格B（下稱：B組購樓意向登記表）（合稱為：購樓意向登記表）。
  2. 遞交購樓意向登記表的登記人將按照其遞交的購樓意向登記表而被分為兩組，即A組及B組，以決定揀選指明住宅物業的優先次序。
  3. 登記人（或其獲授權人士）須於 2018 年 1 月 20 日至 2018 年 1 月 29 日於辦公時間（即星期一至星期日 上午 10 時 30 分至下午 8 時）期間到九龍尖沙咀彌敦道132號美麗華廣場一期5樓君譽峰售樓處（下稱：指定會場）遞交（遞交登記次序不會影響揀選住宅物業的優先次序）：
    - (a) 已填妥及由登記人簽署的購樓意向登記表，每位登記人只可遞交最多1份A組購樓意向登記表及1份B組購樓意向登記表，重複遞交將不會受理；及
    - (b) 購樓意向登記須附有本票：
      - (i) A組登記人必須遞交2張本票，惟該可選擇之住宅物業數目不能少於2個；
      - (ii) B組登記人只可遞交最多2張本票，惟該可選擇之住宅物業數目不能多於2個。
- 每張本票金額為港幣 \$100,000 及抬頭人須為「中倫律師事務所」；及

(c) 登記人的身份證或（視屬何情況而定）護照或商業登記證書或公司註冊證書和董事的身份證副本（如適用）。

遞交購樓意向登記截止時間為 2018 年 1 月 29 日下午 8 時。

4. 已繳交之本票將會作為購買指明住宅物業的部份臨時訂金。
5. 已根據上述第 3 條進行登記的登記人(如登記人為公司,則任何一位董事)須於該 2018 年 1 月 30 日下午 6 時至 7 時（登記人報到時段）攜同其身份證或（視屬何情況而定）護照或商業登記證書、公司註冊證書和董事的身份證（如適用）及購樓意向登記表格的正式收據親臨指定會場，經賣方委託的代理確認並核實身份後方可享有最終抽籤資格。於 2018 年 1 月 30 日下午 7 時任何時間後才到達指定會場的登記人將被取消抽籤資格，其登記將被視作無效。
6. A組登記人及B組登記人之抽籤程序將於 2018 年 1 月 30 日下午 7 時 05 分進行，賣方會將抽籤結果，包括「登記號碼」及「抽籤結果次序」於當日於指定會場公布。登記人將不獲另行通知抽籤結果。每一份A組購樓意向登記表及B組購樓意向登記表可獲分配的籌的數目相等於所遞交本票之數目。當一個籌獲抽中，其相關購樓意向登記的其他籌（如有）於同一次抽籤程序將會取消及作廢。
7. 於 2018 年 1 月 30 日，發售指明住宅物業時段將分為兩節，分別適用於以下兩組已遞交購樓意向登記表格之人士（每一該等組別稱為一組）（分別為：A組及B組）：
  - (a) 首先進行A組揀樓。A組登記人根據抽籤結果分配予該組各購樓意向登記之順序揀選當時仍可供選擇的指明住宅物業，當只餘下一個可供選擇的指明住宅物業，A組即告完結。
  - (b) A組揀樓完成後由賣方酌情決定的合理時間內開始進行B組揀樓。B組登記人根據抽籤結果分配予該組各購樓意向登記之順序揀選當時仍可供選擇的指明住宅物業。

- (c) 當登記人就一購樓意向登記揀選一個指明住宅物業，該指明住宅物業之買方只可以是：
  - (i) 該登記人；或
  - (ii) 該登記人連同該登記人即場向賣方要求加入作為聯名買方之該登記人之一位或多位「直系親屬」。
- (d) 當登記人就一購樓意向登記揀選多於一個指明住宅物業：
  - (i) 如此揀選之指明住宅物業當中最少一個之買方只可以是：
    - (1) 該登記人；或
    - (2) 該登記人連同該登記人即場向賣方要求加入作為聯名買方之該登記人之一位或多位「直系親屬」；及
  - (ii) 每一其他如此揀選之指明住宅物業之買方只可以是：
    - (1) 該登記人（或組成該登記人之任何人）；或
    - (2) 該登記人即場向賣方要求作為買方之該登記人之一位或多位「直系親屬」；或
    - (3) 該登記人（或組成該登記人之任何人）連同該登記人即場向賣方要求加入作為聯名買方之該登記人之一位或多位「直系親屬」。
- (e) 「直系親屬」指該登記人之配偶、父母、子女、兄弟姊妹、祖父母或外祖父母、孫、孫女、外孫

或外孫女，並備妥令賣方滿意的有效證明文件以茲證明。

(f) 賣方保留最終權利決定有關人士是否為合資格的「直系親屬」。

8. 如登記人並無購入任何指明住宅物業或其購入之指明住宅物業數目未達其於購樓意向登記內所填寫意欲購買之數目，登記人（或其獲授權人士）可於 2018 年 1 月 31 日至 2 月 1 日上午 10 時 30 分至下午 8 時內於指定會場辦理取回無利息未被使用的本票。登記人須攜同登記人身份證或護照正本（如以獲授權人士取回未使用的本票，則須攜同登記人身份證或護照副本）及（如適用）登記人之商業登記證書或公司註冊證書副本、有效的購樓意向登記收據正本、及（如適用）有效的授權書及獲授權人士之身份證或護照副本。

#### 先到先得

當抽籤及合資格人士選購指明住宅物業程序完畢後，所有餘下的指定住宅物業（如有的話）將以先到先得形式發售。為了維持指定會場的秩序，如有任何爭議，賣方保留最終決定權以任何方法（包括抽籤）將某指明住宅物業分配予某位有興趣人士及決定將某指明住宅物業出售予何人。

#### **2018 年 1 月 31 日起:**

餘下的指明住宅物業將以先到先得形式發售。有興趣購買餘下指明住宅物業的人士必須親臨賣方指定的出售地點購買其意欲購買的住宅物業。為了維持出售地點的秩序，如有任何爭議，賣方保留最終決定權以任何方法（包括抽籤）將某指明住宅物業分配予某位有興趣人士及決定將某指明住宅物業出售予何人。
